LOUISVILLE, Ky., Sep 30, 2004 /PRNewswire-FirstCall via COMTEX/ -- Humana Inc. (NYSE: HUM) will release its financial results for the third quarter 2004 on Monday, November 1, 2004 at 5:00 a.m. eastern time. The company will host a conference call, as well as a virtual slide presentation at 9:00 a.m. eastern time that same morning to discuss its financial results for the quarter and earnings guidance.
