



## Humana Inc. to Release First Quarter Results on May 1, 2006

LOUISVILLE, Ky.--(BUSINESS WIRE)--March 24, 2006--Humana Inc. (NYSE: HUM) will release its financial results for the first quarter 2006 on Monday, May 1, 2006 at 5:00 a.m. eastern time. The company will host a conference call, as well as a virtual slide presentation at 9:00 a.m. eastern time that same morning to discuss its financial results for the quarter and 2006 earnings guidance.
