



## Humana Inc. to Release Third Quarter Results on October 30, 2006

LOUISVILLE, Ky.--(BUSINESS WIRE)--Sept. 15, 2006--Humana Inc. (NYSE:HUM) will release its financial results for the third quarter 2006 on Monday, October 30, 2006 at 5:00 a.m. eastern time. The company will host a conference call, as well as a virtual slide presentation at 9:00 a.m. eastern time that same morning to discuss its financial results for the quarter and earnings guidance.
