



## Humana Inc. to Release Fourth Quarter Results on February 5, 2007

LOUISVILLE, Ky.--(BUSINESS WIRE)--Dec. 15, 2006--Humana Inc. (NYSE: HUM) will release its financial results for the fourth quarter 2006 on Monday, February 5, 2007 at 5:00 a.m. eastern time. The company will host a conference call, as well as a virtual slide presentation at 9:00 a.m. eastern time that same morning to discuss its financial results for the quarter and earnings guidance.
