## Humana Inc. to Release First Quarter 2023 Results on April 26, 2023

**Louisville, KY** – March 29, 2023 – Humana Inc. (NYSE: HUM) will release its financial results for the first quarter 2023 (1Q23) on Wednesday, April 26, 2023, at 6:30 a.m. Eastern time. The company will host a conference call at 9:00 a.m. Eastern time that morning to discuss its financial results for the quarter and earnings guidance for 2023.
