### **Humana Inc. to Release First Quarter 2019 Results on May 1, 2019**

**Louisville, KY** – April 8, 2019 – Humana Inc. (NYSE: HUM) will release its financial results for the first quarter 2019 (1Q19) on Wednesday, May 1, 2019 at 6:30 a.m. eastern time. The company will host a conference call at 9:00 a.m. eastern time that morning to discuss its financial results for the quarter and earnings guidance for 2019.
